COUNTY UPDATE

Steuben County Legislator Kelly Fitzpatrick spoke on the County Update, the following items were addressed.

- Tax Budget Public Presentation, there was a 1.07 % Levy Increase, the Tax Rate will go down. Everyone will receive either a flat tax bill or slight increase because of full assessment last year, nothing dramatic. The budget has not been fully adopted yet.
- The County is not holding as many people in the jail anymore.
- All roads identified in poor condition have been repaired.
- Emergency CHIPS aid is now gone.
- Spoke with Brian briefly about Empire Internet, rural areas
- Kelly will be revisiting and talking to Empire to come back to Savona, we are currently 33 people short for interest to bring Empire to Savona. She will be speaking to the sales rep in regards to that. If Empire becomes available in Savona it will open up more opportunities in surrounding and other rural areas.
- There is a four county co-op being put together soon for upstate revitalization grant money to put internet in rural areas that don't have it,
- Early voting was in full effect this year.
